The Work Opportunity and
Welfare-to-Work Tax Credits

Features:

On March 9, 2002, P.L. 107-147 reauthorized the WOTC and the WtWTC for a 24-month period, retroactive to the expiration date, December 31, 2001. These tax credits are incentives to encourage employers to hire 9 groups of job seekers with barriers to employment.

- **Employers:** Send your IRS Form 8850 (certification request) and ETA Form 9061 or 9062 to your State Workforce Agency WOTC Coordinator.
- **Economic and Community Development Agencies:** Contact your State WOTC Coordinator to learn how you can help businesses in your area earn *federal income tax savings of up to \$8,500 per “new” hire.*
- **Social Service Delivery and Workforce Development Agencies:** Contact your State WOTC Coordinator to learn how you can help long-term welfare recipients and eight other targeted groups of job seekers gain this competitive edge in the job market.
